WHEREAS there is no incumbent in the position of Police Secretary to Deputy Commissioner. As a Non-Competitive/PJC title, there is no list of eligible candidates, and

WHEREAS the Nassau County Police Department has stated that they will no longer be pursuing the Police Secretary to Deputy Commissioner title,

RESOLVED, That the title Police Secretary to Deputy Commissioner be deleted from the County Master Title Index.

There being no further business, the Commission adjourned to go into Executive Session.
